## **2026: Alignment and Realignment in Osun**

s Osun state moves towards another election year, there are already indications that the journey will be interesting, this is as political actors are beginning to form new alliances, create new blocs within different parties.

What appears like a renewal of battle, is the re-entry of former Governor, Ogbeni Rauf Aregbesola into the political space.

Aregbesola after joining camps with Nasir Elrufai, Atiku Abubakar to form a coalition which later adopted the African Democratic Congress (ADC) later emerged as National Secretary of the party and thereby making him the leader of the party in the state.

Recall that the All Progressives Congress (APC) had in 2024 suspended Aregbesola from the party stating through a letter written

The alleged him of factionalizing the APC by forming the Omoluabi Caucus splinter group; allegedly collaborating with opposition parties to destabilize the APC in Osun State; publicly criticizing party leaders, including President Bola Tinubu, Chief Bisi Akande, and former Osun governor Gboyega Oyetola; refusing to participate in or support APC activities within the state; and refusing to vote for the party since the 2019 general elections.

Aregbesola in response said he never left the APC but that the party left

He said, "The week we created the Omoluabi group, we were dragged to court and warned not to use the name of the party I helped build with my sweat. Eventually, we were expelled. I never left APC, the party left me."

Now that Aregbesola is back to the Osun state government election scenario, it is unclear yet who the candidate of ADC in 2026 will be but sources revealed that the party might cede the ticket to the west, leaving the one time SSG, Alhaji Moshood Adeoti and the one time Speaker of Osun Assembly, Rt Hon. Najeem Salam in the ring.

Osun Spring notes that while it is clear that the ADC will not be aligning with APC in any way but is unclear if there would be no alliance between the PDP and ADC or even between Governor Ademola Adeleke and Ogbeni Rauf Aregbesola.

Although recent statements by Governor Adeleke have said that he will not be joining APC, the Governor and the PDP in Osun have systemically endorsed President Tinubu for a second term in office which is raising further questions by citizens of the state. We are not sure what that will birth in Osun, especially after the 2026 Governorship Election.

Osun Spring urges all political leaders and followers to ensure that as we approach the election season, there is no campaign of calumny, spreading of fake news or abuse of the social media space.

We also call security agencies in the state to ensure adequate protection of lives and properties, while staying professional and fair to all parties throughout this election period.

# Osun 2026: We will rig Adeleke out using police, INEC -Oyetola

ormer Osun State G o v e r n o r , Gboyega Oyetola has said that it will be difficult for any aspirant who eventually emerges candidate of the All Progressives Congress (APC) in the forthcoming 2026 Governorship Election to defeat the incumbent Governor of the state, Senator Ademola Adeleke, Osun Spring has learnt.

Oyetola added that to ensure that APC wins Osun in 2026, he has secured the cooperation of the Nigeria Police Force and the Independent National Electoral Commission (INEC).

According to sources present a close door meeting of top leaders of the APC in Osun on Friday at the Ilerioluwa house in Osogbo the Osun state capital, Oyetola attributed the loss of Osun APC in 2022 Governorship election to the refusal of late President Buhari to instruct INEC and the Police to work in its favour.

The source noted that he added that being close to President Bola Tinubu aided him to ensure that he blocked the move by people trying to bring Adeleke to the APC while promising President Tinubu that the party will win 2026 election as well as deliver the state for the President's reelection come 2027.

The Minister of Marine and Blue Economy also announced to people stakeholders of APC in Osun state that he will not be contesting the 2026 Governorship Election asking aspirants to ensure they work effectively to win the election adding that aspirants should make sure they all work together with whoever emerges the candidate of the party.

The source disclosed that Oyetola maintained that he has stood as a guarantor for Osun APC before President Tinubu noting that if Osun APC loses come 2026 it will bring his political career to an absolute end.

The source said,

"Oyetola has eventually told us that he will not be contesting for Governor in 2026. In fact he told us that Adeleke is too powerful to be defeated and he has secured the cooperation of both the Police and INEC to ensure that we win 2026 Governorship Election.

"He said that we lost the 2022 Osun Governorship election because President Buhari refused to instruct the Police and INEC to work for us.

"Oyetola said that he was the one who blocked Adeleke from joining our party, APC, he told us that he had promised President Tinubu that APC will win in Osun and the implication of this is that if APC loses, his own career as a politician has come to an end.

"He told all aspirants that they have work to do at the grassroot level and they must be ready to work together and support whoever emerges candidate of the party eventually", the source noted.

On the local government crisis, the source noted that Oyetola said it is a deliberate strategy to frustrate the Adeleke administration making sure that he is unable to deliver campaign promises and thereby turning the people against the Governor.

The source noted that he added further that he will ensure that the money is not paid to Governor Adeleke until the end of his first term in office.

"Oyetola told us that on the issue of local government crisis, the stoppage of local government fund is a deliberate strategy they he deployed to ensure that Adeleke government is not able to achieve anything especially at the grassroot level and ultimately turn the people against him.

"Infact he told us that we should rest assured that he will make sure that Adeleke does not get the local government fund till the end of this his tenure in office", the source added.

Aspirants in the APC for the 2026 Governorship Election are: Senator Babajide Omoworare, Alhaji Bola Oyebamiji, Dr Akin Ogunbiyi, Prince

Dotun Babayemi and Senator Mudashiru Hussein.

Osun Spring reports that of all the aspirants, Senator Ajibola Basiru who is also the National Secretary of the party was absent at the meeting.

Reacting to this development, the Director of Media, People's Democratic Party in Osun State, Oladele Bamiji, noted that the decision of former Governor Oyetola not to contest is because he is aware of the popularity of Governor Adeleke and does not want to be defeated again.

The statement added that Governor Ademola Adeleke had won series of elections in the past because of the love of people behind him and is not afraid of going to poll but he is confident of victory.

"Reports have emerged that the defeated former Governor Gboyega Oyetola will not contest the 2026 governorship election in Osun State. While some have tried to sell this as a statesmanlike retreat, we see it for what it truly is - a calculated face-saving measure by a man thoroughly rejected by his

people and discredited by his own actions.

"Let us refresh our memories. Governor Ademola Adeleke has been a consistent thorn in the flesh of Osun APC since 2017. Against all odds, he defeated their candidate in nine out of ten local governments in the Osun West Senatorial Bye-election held to fill the seat of his late brother, Senator Isiaka Adetunji Adeleke. That victory rewrote political calculations in Osun as well as effectively stamping a new era of electoral bravery in the people of the state.

"In 2018, Senator Adeleke again won the governorship election, only to have his victory cruelly snatched through INEC's infamous "inconclusive" declaration, a charade supervised by Professor Fuwape of FUTA. What followed was a bloody and manipulated runoff that barely produced a 400-vote lead, fraudulently installing Gboyega Oyetola as governor.

"Mr Oyetola entered office not as a people's choice, but as a

beneficiary of electoral robbery and he knew it. Unsurprisingly, he governed with crass detachment, neglecting real development while obsessively waging a senseless war of attrition against his former boss, Ogbeni Rauf Aregbesola, under whom he served for eight years as Chief of

Staff. "Instead of uniting the party and focusing on governance, Oyetola chose vendettas, alienated stakeholders, and distanced himself from the grassroots. He imagined that being a cousin to President Bola Ahmed Tinubu gave him unlimited license. But even nepotism has its limits when competence and compassion are absent.

"In 2022, the people of Osun State spoke again, louder this time. They overwhelmingly elected Governor Ademola Adeleke, who defeated Oyetola at the polls, fairly and squarely.

"Now, however, disturbing signals are emanating from a factional APC stakeholders' meeting held at the instance of the

same failed former governor. Reports say Oyetola has resumed his dangerous political games, boasting that he has secured the backing of "key institutions"- INEC and the security agencies, to hijack the 2026 elections for his party. His justification? "I am the President's cousin."

"He even allegedly bragged about masterminding the unlawful withholding of statutory allocations meant for local governments in Osun State, all to punish the same people he seeks to govern again. Is this how to be a cousin to the President? Weaponizing family ties to inflict suffering on ordinary citizens?

"Can such a man, who abuses access to power to deprive his people, be taken seriously when he resurfaces to lead APC campaigns in Osun? This is not just a question of morality, it is a matter of political and ethical reckoning.

"Unfortunately for him and his ilk, the people of Osun are not cowards. History has shown that they do not bow to oppressors, no matter how highly connected they may be.

"I have personally received countless communications from across the state, expressing dogged support for Governor Adeleke and the PDP. The people are not just grateful for the tangible progress achieved in the last two and a half years, they are ready for an electoral showdown. They are prepared to once again reject Oyetola and his brand of entitlementdriven politics.

"This coming election cycle will once again confirm the political resilience and maturity of Osun people. And more importantly, it will serve as a definitive lesson in how not to be a President's cousin - by Gboyega Oyetola's example.

"President Bola Ahmed Tinubu must be alert and beware of his pampered cousin, who appears determined to damage his political credentials and legacy just to secure a political lifeline he no longer deserves", the statement reads.

sun in the last few days have encountered series of conversations ahead of the 2026 governorship election as both the People's Democratic Party (PDP) and All Progressives Congress (APC) gets ready to claim the votes of Osun people.

The conversation becomes heated as it was reported that former Governor Oyetola while meeting the Osun APC Stakeholders with exception of the party's National Secretary, Ajibola Basiru made certain comments on the plans of the party over the governorship election.

The PDP in a statement by its chairman, Hon. Sunday Bisi raised an alarm over the grand plot reportedly disclosed to the APC Stakeholders by the Minister, describing the alleged utterances as the most brazen declaration of intent to destroy democracy and a condemnable signal to abuse state power to deny Osun people the legitimate rights to choose their leader in a

The PDP while reprimanding the Minister over his alleged threats to rig the 2026 governorship elections in Osun state declared that Osun people rejects threats and intimidation as a tool for politicking, vowing that Governor Adeleke will win the 2026 election because he has solid support of the people as his governance records are superlative and he has God who gives

The statement reads, "The Osun state chapter of the PDP is alarmed by several media reports of some inciting statements credited to the former Governor of Osun state and current Minister of Blue Economy, Adegboyega Oyetola on his role in the withholding of Osun local governments allocations and the plan to thwart the will of electorates in the forthcoming 2026 governorship elections.

"We waited for more than 48 hours with the expectations that the Minister will deny the reports but till now, he has remained silent. We are encouraged therefore to belief that the Minister actually made those threatening remarks.

"For records purpose, the Minister was alleged to have told the closed door, high level caucus meeting of the party the following:

"I blocked Gov Adeleke from joining the APC. Otherwise, all

"I gave a guarantee to Mr. President that APC can win in Osun without Governor Adeleke:

"We lost the 2022 election because Buhari refused to instruct INEC and the Police to work for APC;

"I have secured the Cooperation of the Police and INEC to ensure that APC wins the Osun 2026 Gubernatorial Election;

"I have employed federal might to prevail upon the Attorney General of the Federation not to recognize the judgment of the Court of Appeal, which clearly recognized the election of the PDP chairmen and councilors.

"The Attorney General is working on a loophole that will allow the withheld local government funds to be released to the courtsacked APC chairmen and Councilors.

"Otherwise, the Osun State withheld funds will not be released until after the Gubernatorial Election in 2026, in order to turn the grassroots against Governor Adeleke.

"As a party, we have no issue with the Minister's position on the recent defection politics, we however challenge the Minister to deny and clarify other statements he allegedly made at the said state caucus meeting as they pose serious danger to democratic practice, undermine the credibility of critical state institutions and constitute gross abuse of powers and violations of the constitution.

"While we are of the considered view that President Bola Tinubu is not aware of the open threats to sack democracy in Osun by his cousin and the Minister of Blue economy, we call on Mr President to sanction the Minister for dragging the names of the Federal Government into disrepute.

"We also call on Mr President to counter-order the Attorney General of the Federation to obey the Court of Appeal judgement which recognizes the duly elected PDP chairmen and councilors and release Osun state local government allocations without further delay.

"We are also alerting men of goodwill and the diplomatic community of the open declaration of war on the people of Osun state by a Minister who is still bitter about his rejection at the poll by the good people of Osun state in 2022.

"We inform the global community of an open genocidal threat to democratic practice as Osun people will defend their votes irrespective of the threats from anti-democratic elements", the PDP statement reads.

Reacting to the PDP statement. Special Adviser on Media and Communications to the Minister of Marine and Blue Economy Dr. Bolaji Akinola described the statement as a fictional allegations adding that its a desperate cry from a failing party.

The statement added that the claims in the PDP's statement as false, malicious, and baseless adding that It is a deliberate smear campaign borne out of paranoia, fear, and desperation.

The statement reads, "Our attention has been drawn to a shameful and poorly scripted press statement issued by Sunday Bisi, Chairman, Osun State chapter of the Peoples Democratic Party (PDP). The statement is riddled with lies, fabrications, and reckless propaganda aimed at maligning the person of the Honourable Minister of Marine and Blue Economy, His Excellency, Adegboyega Oyetola (CON), and by extension, the All Progressives Congress (APC).

"Let it be made abundantly clear that every single claim in the PDP's concocted tale is false, malicious, and baseless. It is nothing more than a deliberate smear campaign borne out of paranoia, fear, and desperation, as the PDP stares down the barrel of a looming defeat in the 2026 Osun State Governorship Election.

"Contrary to the irresponsible fabrications released by the PDP, the Honourable Minister did not — and could never have - uttered any of the statements attributed to him. The entire press statement is a classic example of political fiction-writing, reflective of a party that has become increasingly unhinged in the face of its declining popularity.

"For the records: At no point did the Honourable Minister threaten to rig any election. He remains a firm believer in democracy and the rule of law — a legacy he upheld throughout his tenure as Governor of Osun State and continues to embody in his current capacity as Minister.

"The Honourable Minister has no control, nor has he ever claimed to control INEC, the Police, or the Attorney General of the Federation. The wild claims about "federal might" are not only laughable but an insult to Nigerians' intelligence and democratic institutions.

"The allegations concerning local government allocations and court rulings are mischievous distortions\* by a party trying to mask its own incompetence in governance and failure to engage constructively on matters of public interest.

"The PDP's ridiculous resort to dragging the diplomatic community into their web of lies speaks volumes about their intentions — \*to incite, confuse, and distract\* the public from the real issues plaguing Osun State under their watch.

"We challenge the PDP to produce any verifiable evidence audio, video, or minutes of the alleged meeting - to support these outrageous claims. Until then, the world should treat their statement as nothing but what it is: the dying gasp of a political party on the verge of another resounding electoral defeat.

"The Honourable Minister and the APC remain committed to free, fair, and credible elections in Osun State and across Nigeria. We urge the good people of Osun to ignore the distractions of the PDP and stay focused on the mission to restore competent, people-oriented governance in 2026.

"Enough of the theatrics. Osun deserves better than a party that governs by press release and paranoia."

Osun Spring reports that the Independent National Electoral Commission (INEC) has fixed August 8, 2026 as the date for Osun 2026 Governorship Election but while all the stakeholders in the PDP seems to have adopted Senator Ademola Adeleke as the party's flag bearer while the APC may have a long way to go in selecting its flagbearer.

## LG Allocations: Osun PDP Drags Oyetola, AGF Fagbemi to Western Embassies, Rights Groups

The Osun State chapter of the Peoples Democratic Party (PDP) has taken its grievances against the Attorney General of the Federation, Mr. Lateef Fagbemi (SAN), and the Minister of Marine and Blue Economy, Mr. Adegboyega Oyetola, to the doorstep of international embassies and global rights organisations over what it describes as "deliberate disobedience" to a subsisting court judgment on local government leadership in the state.

In a statement signed by its Chairman, Hon. Sunday Bisi, and released to the press in

Osogbo on Monday, the ruling party in Osun accused the duo of orchestrating the ongoing local government crisis by allegedly frustrating the implementation of a Court of Appeal judgment that affirmed the legality of PDPelected local council chairmen and councillors.

"Rather than ensure compliance with the court order. Mr. Oyetola has been allegedly using his family ties with President Bola Tinubu to facilitate the continued illegal withholding of Osun's local government allocations for over five months, an act that has no legal basis," he said.

The PDP claimed that despite clear judicial

pronouncements, both the AGF and the Blue Economy Minister are "insisting on paying local government funds to court-sacked APC chairmen,". The party said the move constitutes an assault on constitutional democracy and a dangerous precedent in governance.

"We find this development worrisome and an open threat to democratic governance. "We call on Western embassies and international rights organisations to sanction these federal officials whose actions threaten the rule of law and the sanctity of the judiciary," it said.

The party further urged the

international community to impose visa bans and other punitive measures on the officials, alleging that their actions undermine democracy in Nigeria.

Highlighting the legal journey that led to the Court of Appeal judgment in favour of the PDP, the party noted that rather than uphold the law, federal actors have continued to interfere in the state's local governance structure — "a brazen breach of Nigeria's constitution and judicial independence."

The PDP also called on rights groups like Transparency

International, Amnesty International, International Crisis Group, and the European Union, among others, to open investigations into the crisis and issue reports on what it called "antidemocratic threats in Osun State."

"We request that Osun's 2026 gubernatorial election be adopted as a litmus test for Nigeria's 2027 general elections, with a spotlight on the risks and democratic backsliding being orchestrated by federal enablers," the statement said.

According to the PDP, the

party will not relent in escalating its protests to the global stage until all legitimately elected local government officials are allowed to function and Osun's allocations are released without further

"We will continue to petition relevant international institutions until justice is done and democracy is respected in Osun State," the party vowed.

As of press time, neither the Office of the Attorney General nor that of the Minister of Marine and Blue Economy had issued an official response to the allegations.

# Osun 2026: The Journey Begins • I remain in PDP- Adeleke • Uneasy calm in APC • ADC to test run with Osun Election

he stage is beginning to set as the Independent National Electoral Commission has officially released the timetable for the 2026 Osun State Governorship Election, picking August 8, 2026 as the day Osun people will get to decide who leads them for another four years.Osun Spring reports that with the new electoral act, all political parties willing to participate in the election will have to conduct a primary election between November and December 2025.

Contrary to speculations and rumours making the round, Governor Ademola Adeleke has reaffirmed his membership of the People's Democratic Party (PDP) and denied reports of his decamping to the All **Progressives Congress** (APC).

The governor in a statement by his Spokesperson, Mallam Olawale Rasheed noted with concern the widespread rumour and has reassured his supporters and admirers that he remains a member of the PDP and the leader of the party in the state.

He restated his preoccupation with the implementation of the administration's five point agenda and urged Osun people to ignore fake news, promising more delivery of good governance and democratic dividends.

"I assure the good people of Osun that I remain part and parcel of the PDP family. I am not defecting to any party", the governor noted.

In a related development, Governor Adeleke also debunked his rumored defection to African Democratic Congress (ADC) or alliance with former Governor Rauf Aregbesola ahead of the Governorship Election.

Responding to media

publication and enquiries, the Spokesperson to Governor Adeleke, Mallam Olawale Rasheed affirmed that Governor Adeleke remains in Peoples Democratic Party (PDP) and is going to win, with wide margins, the 2026 governorship elections on the platform of the PDP.

The statement reads "Our attention has been drawn to news reports and media enquiries about the imminent defection of Governor Adeleke to the ADC or alignment with ADC big wigs ahead of the 2026 governorship race. There is no truth in those publications and speculations.

"First of all, we, the PDP Osun, have already adopted and endorsed President Bola Ahmed Tinubu for the 2027 presidential election, so there is no alliance with ADC.

"Secondly, Governor Adeleke has no alliance with anvone in ADC. He remains in PDP, will run in PDP, and needs no alliance with ADC to win with a wide margin in 2026.

"The Osun electorate supports Governor Adeleke because of his impressive performance since he came to office. That good work is still ongoing and Osun people are committed to sustaining the delivery of good governance by reelecting Governor Adeleke in 2026", the Spokesperson was quoted as saying.

Governor Adeleke urges PDP members to forge ahead with the ongoing strengthening of the party structures across all levels to prepare for fresh victory next year", the statement from the Spokesperson concluded.

Meanwhile, the coast is not clear within Osun APC as it is now official that former Governor Gboyega Oyetola, who is now the minister of Marine and Blue Economy will not be contesting the 2026 Governorship Election.

Osun Spring reports that



prior to his announcement at stakeholders meeting in Osogbo, the Osun state capital, the entire Osun APC structure have said to allude to Oyetola being the determining factor of the flagbearer of the APC come 2026, adding that the former Governor has a right of first refusal ie he wants to contest again.

Oyetola instead asked all aspirants who have indicated interest to go and gather support from party members ahead of the party's primary for which date has not been fixed.

He said, "You should all avoid the campaign of calumny and be your brother's keeper. I am no longer interested in vying for the governorship ticket with you.

"You all can see that the APC remains the party to beat anytime and any day. As of today, we are receiving people into the party, and many are still coming.

"This development has further attested to our vibrancy, potency and

formidability. This has always been my dream to build a virile, potent and formidable party that would return the progressives to government."

Osun Spring reports that aspirants in the APC are, Alh Bola Oyebamiji, Senator Mudashiru Hussein, Prince Dotun Babayemi, Dr Akin Ogunbiyi, and Senator Babajide Omoworare.

The National Secretary of APC, Senator Ajibola Basiru will also be vying for Governorship, even though his fate is unknown as Osun Spring reports that he was absent at the stakeholders meeting.

For the ADC which former Governor Rauf Aregbesola is now the National Secretary of the party, Osun State may be its tool to test run its upliftment in Nigeria's political space.

Osun Spring recall that coalition of opposition forces has formally adopted the African Democratic Congress (ADC) as its platform to challenge the ruling All Progressives

Congress (APC) in the 2027 general election but in order to achieve this they'll need to test their strength with gubernatorial elections that precede the Presidential election.

Aregbesola, said he agreed to serve as the Interim National Secretary of the African Democratic Congress because Nigeria's political scene is dominated by parties lacking clear ideological direction.

"Sadly, in Nigeria today, we cannot say the same about many of our political

"Our political landscape is plagued by parties that lack ideological depth. They are empty shells emerging and splitting, not over policy or principle, but over power and personality. There is little regard for the people, and even less for the country."

Weeks after, Aregbesola returned to Osun to meet The Omoluabi Progressives, his faction that pulled out of APC to

also join ADC assuring them of victory come 2026.

"We are not here to trade insults. We are here to restore what has been lost — dignity, competence, and direction.

"This party is for everyone. We welcome you, not as enemies of others, but as Nigerians determined to chart a better path forward. We know the game distractions, smears, provocations. But we will not play it.

"We are on a mission, and we will stay focused, building quietly, consistently, and with conviction.

"We used those same principles in Osun to navigate the worst economic crisis in Nigeria's history and still delivered measurable progress. This is what Nigeria needs now: grounded, proven, and people-driven.

"We are stepping into a new chapter, one of responsibility, restoration, and meaningful results. The struggles of the past were not in vain. They've prepared us to lead with clarity and conviction. The best of what we have to offer is still ahead."

## Experts hail Adeleke as mining sector reform yields result

The efforts of the Ademola Adeleke administration in reforming the mining sector of Osun have attracted commendation and accolades, as experts revealed that the reformation is not beginning to yield quality results.

The Osun State Government had on the 30th of September, 2024 sealed up the business premises of Segilola Resources Operating Limited, following a Court Order permitting the State to distrain the company for various flagrant tax violations and failure to disclose fully the employees directly and indirectly involved in its business activities, obstruction of tax processes by failing to provide timely tax information and documents.

Segilola Resources Operating Limited is one of the major companies carrying out mining activities and mineral exploration in the State as a subsidiary of Thors Explorations Limited listed on London and Toronto Stock Exchanges.

The Osun State Government had raised serious concerns about the operations of the Segilola Gold Project, managed by subsidiaries of Thor Explorations Ltd, a UK- based company listed on the Toronto Stock Exchange.

According to Prof. Lukman Jimoda, the Special Adviser to the Governor on Mining and Mineral Resources, the state's investigation revealed various unethical business practices, including alleged tax evasion, use of proxies, and failure to comply with environmental rules and regulations.

The companies involved-such as SINIC Engineering, ATF Consulting, Monurent Nigeria, and others-are reportedly engaged in outsourcing employment and operations to

undisclosed third parties without proper documentation or environmental compliance.

Prof. Jimoda highlighted that the federal constitution places environmental oversight under the concurrent list, allowing the state to assess companies' operations for economic and environmental impacts.

He emphasized that the Segilola project, despite its significant production since 2019, has resisted complying with extant laws like the Personal Income Tax Act (PITA) and the Company Income Tax Act (CITA) which govern tax levies.

He also expressed concerns over pollution, including particulate emissions and possible acid drains from waste rocks, which pose serious environmental risks to the

The state government then demanded the payment of accrued taxes and environmental development levies, as well as proper documentation for all involved parties.

The Special Adviser stressed that Osun has not received its due revenue from the Segilola project for over three years, despite its bankable gold production since 2019.

Weeks after, the Federal government stepped in, after a conflict resolution meeting initiated by the Minister of Solid Mineral Development, the parties agreed to jointly work together to address four major areas of disagreement raised by the Osun state government against Thors Explorations Limited.

The issues listed by the state government include resolution of Osun shareholding in the Segilola Mining company, tax payment by the firm, environmental degradation, disputed mining fields among others.

s former Governor Gboyega Oyetola officially stepped down from the 2026 Governorship Election, the hurdle is now left for 6 aspirants to slug it out.

Osun Spring reports that while five aspirants namely Alh Bola Oyebamiji, Senator Mudashiru Hussein, Prince Dotun Babayemi, Dr Akin Ogunbiyi, and Senator Babajide

When asked about the fate of Ajibola Basiru, the source declined comment but noted that it is obvious the odds are not in favour of the one time Osun central Senator.

"I can con fir m authoritatively that Alhaji Oyetola deliberately told everybody to go and work so that he will not be perceived as a dictator, we all know that he had chosen Bola Oyebamiji as his preferred choice but if he makes the announcement, it will further divide the party.

"Though some of us in the party would have preferred someone else but then where it falls in our party, we will align.

"For Ajibola Basiru, he knows that the odds are not in his favour, I guess he just wants to try his luck or perhaps test his popularity.

"What we don't know for now is the type of primary that will be adopted because this also goes a long way in determining who becomes our candidate.

"It is also not certain if our party will officially announce that we are zoning the ticket to a particular senatorial district or not because as of today we have aspirants from the three senatorial districts and these are the things we would need to check as we proceed.

"Since Alhaji Oyetola is

no longer in the race, it is now Oyebamiji, Omoworare, Hussein, Babayemi and Ogunbiyi that will show us their capacity, especially in terms of mobilization."

Osun Spring reports that there was a bit of exchange of words between the camp of Bola Oyebamiji and Ajibola Basiru in the time past when the duo made it open they'll be vying for Governorship.


# Uncertainty trails Osun PDP Senators, Reps after defecting to APC

There is a bit of confusion hitting the camp of Senators and members of the House of Representatives from Osun state after defecting from the People's Democratic Party (PDP) to All Progressives Congress (APC).

Osun Spring reports that the Senators representing Osun East and Osun Central Senatorial District, Senator Francis Fadahunsi and Senator Olubiyi Fadeyi as well as member representing Obokun/Oriade Federal Constituency, Hon Wole O k e; m e m b e r representing Ijesha S o u t h F e d e r a l Constituency, Hon Sanya Omirin and the member representing Ife Central/East/North/South Federal Constituency, Hon Taofeek Ajilesoro have all joined APC.

However, PDP in a communique issued at the end of its 101st National Executive Committee Meeting in Abuja states that such a defector is liable to lose their seat at the National Assembly stating that the mandate belongs to PDP. According to the



determination to preserve all the electoral mandate given to our Party by Nigerians across the country, NEC directed the National Working Committee to take immediate legal action to recover the seats of all serving members of the National and State Assemblies elected on

the platform of the PDP but defected to another Party.

"By virtue of the self-executory provision of Sections 68 (1) (g) and 109 (1) (g) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) such defectors have irredeemably lost their seats, there being no

division or merger with regard to the PDP."

APC on its part warned defectors to beware of fake assurance as the party is not granting automatic return tickets to all sitting members of the National Assembly.

The party described the claims as "fake news," urging members of the public to disregard them. In an official statement by the APC's National Publicity Secretary, Felix Morka, dismissed the reports as fabricated and misleading. He clarified that no such decision had been made by the

party and that the report circulating online did not originate from any official party channel.

"The report is fake news a n d s h o u l d b e disregarded in its entirety as it did not emanate from our great party," Morka stated.

Osun Spring reports that while defectors quoted the PDP crisis as their reason for leaving the party and joining the APC, there might be a slight chance that they expect to get the ticket of the APC that they just joined to remain in the National Assembly which at the moment is not clear.

## **OSUN IGR:** The Numbers Shut Up Naysayers

ometime in 2023, a former media aide to ex-Governor Gboyega Oyetola, Mr Ismail Omipidan tried to spin away the reality of the incredible turnaround that the finances of Osun state has undergone under the leadership of Governor Ademola Adeleke. Typical of his ways of seeing doom where progress is quite visible, Mr. Omipidan obviously choose to play politics with numbers in a piece he authored then by erroneously inferring that Internally Generated Revenue (IGR) of the state for the 2023 fiscal year fell short of what was inherited.


This similar line was echoed by Senator Ajibola Basiru, the National Secretary of the All Progressives Congress (APC) in January this year when he concluded that Osun IGR is 'alarming low' under Governor Adeleke. Just like Mr. Omipidan, Senator Basiru tried to create an impression of regression, whereas the reality of things in Osun was that of progress and cheering promise of prosperity.

What, I believe, both of them missed, was the fact that numbers don't surrender to politics because they don't lie. From the records, Osun IGR in 2022 when Governor Adeleke assumed office was N24.7 billion and by the end of the 2023 fiscal year, it has grown to N27.72 billion, representing a 13.28 percent increase. That was a progress that never happened under the supposed 'encyclopedia of finance' throughout his four years time in office as the biggest growth in internal revenue recorded was a 12.24 percent in 2019 fiscal year.

Things got even more better in the 2024 fiscal year as Osun realized a staggering N54.7 billion revenue internally, representing an incredible 97.31 percent increase. That is an exponential growth and even worst of critics of Governor cannot but accept that they have been wrong about him, after all.

Looking at the numbers, it is too big to be real. But it is actually real. And to understand what happened, take a pause and observe the policy direction and institutional reforms undertaken in the last two years by the Adeleke administration will provide a clear understanding on how the growth in the state's IGR was achieved.

Since he assumed office, Governor Adeleke has not left anyone in doubt about his resolve to improve the state's IGR without burdening the people with additional tax. At first, cynics or perhaps, naysayers raises doubt on such possibility, wondering how can IGR grow without putting the burden on the



people

Governor Adeleke, however, believe it is possible, and in January 2023, outlined his plan to reform "several sectors to block revenue leakages and stop diversion of state assets" aimed at re-engineering the financial system of the state. This led to the introduction of tax harmonisation system and digitalisation of revenue collection; blockage of revenue leakages; expansion of revenue sources and enforcing compliance.

And, as we can all tell now, it appears the problem is leakages and blocking it has churned out more money for Osun than imagined. The interesting thing here is that the reforms carried out by Governor Adeleke eliminated, to a large extent, the unwholesome practice of double taxation that frustrate businesses. As much as Osun internal revenue grows, businesses in the state are saved the dilemma of paying multiple taxes as it was the practice in the past with the harmonised taxation system.

Such a shift is beneficial to the economy, meaning that businesses will fare better and enable growths. That is because harmonising taxes, in general, free-up funds from excessive taxation that hurts businesses and contribute to high cost of living that is associated with high price of goods and services. This is a cheering development because it signal to investors out there that Osun is for business growth and not otherwise.

From all indications, Osun has taken the leap for remarkable progress and the future looks rosy. Not just the finances of Osun is receiving life under Governor Adeleke, critical infrastructures that will engender prosperity for now and the future are being brought alive. Governor Adeleke promised to take Osun out of the abyss of ruins and set it on the path of enviable progress, and he is doing just that.

If the achievement in the state's IGR is telling us anything, it is that Osun is in the right hand and that the progress we are seeing across sectors, including the finances of the state, will not be stopping anytime soon. In fact, the IGR figure for Osun this year may likely outclass what was realized in the 2024 fiscal year as the Q2 financial report recently released showed the state has earned a whooping N30bn in just six months from internal sources.

On the whole, automated revenue collection is driving financial growth of the state. When it was initiated, naysayers argued it would not make any much difference. But that is not the case at the moment, as not only did it ensure convenience and swiftness in payments, but also deepens transparency in revenue collections. The result is a significant growth in revenue generation, which has an absolute advantage that guarantees a healthy financial condition for the state.

## APC Aspirants Are Ego Shoppers, Adeleke Will Beat Any Opposition Candidate in 2026 — Osun PDP

The Osun State chapter of the Peoples Democratic Party (PDP) has declared that the 2026 governorship election will be a walk in the park for the incumbent, His Excellency, Senator Ademola Jackson Nurudeen Adeleke, regardless of whoever the opposition fields as candidate.

# Governor Adeleke pays 11th Month Half Salary Arrears, clears Contributory Pensioners Half Salary Arrears

overnor Ademola Adeleke of Osun State have paid civil servants in the state the 11th month half salary arrears owed by previous administrations

The Governor had also cleared the salary arrears of pensioners owed by previous administrations.

Osun spring reports that there are 17 months more half salary arrears to be paid to civil servants in the state, bringing the total arrears to 30 months.

The payments cut across all sectors, including LGAs, tertiary institutions, core

civil service, parastatals, and even political office holders at that time.

In a statement signed by Kolapo Alimi, Commissioner for Information and Public Enlightenment, the government accused past administrations of failure, stating that it was working to "right the wrongs of the previous administration.

"Governor Adeleke is a compassionate leader and doesn't take pleasure in the pains of the people, more else, those who rendered services to the state.

"He's paying the salary owed by the previous administration to bring relief for those owed and also to



stimulate the state economy as those money



ends up in the economy through the buying of essential needs.

"Paying this money means that the Governor prioritises the welfare of the people and always prepared to address failings of the past administration," the statement read.

Reacting to the payment on social media, a civil servant identified as Obadare Olalekan confirmed receiving the payment while commending the Governor for not removing tax from it since it was taxed ab initio.

On his Facebook page

he said, "Yes, I received it early hour of today. The amazing part of it is that what I received today was 5k more than the first half paid by Aregbesola then. This suggests to me that Gov Adeleke did not remove tax for the second time"

Another Facebook user identified as Tobi Fadipe said in a post that his mother who is a civil servant asked him to appreciate the Governor adding that despite the withheld local government fund, Governor Adeleke have not defaulted in salary payment.

He said in mixed English, " Dear Gov Adeleke My Mama say make I thank you o. She said despite the withholding of LG allocations by the Fed Govt since February, you still haven't owed any worker for a month.

"And I come still hear say you pay another half salary. I am beginning to relate to how Lagosians got addicted To Tinubu all those years when OBJ withheld Lagos LG allocations.

"And the other day, I read about the reduction of our state debt by 65bn over the past 2 years. Considering where we are coming from, this is quite huge. Well done sir."

# First Ila dual carriageway: Adeleke's deserving gift to the 'forgotten ones'

he crowd at the entrance to the palace of the Orangun of Ila, Oba Wahab Oyedotun, on Monday, July 2021, awaiting the arrival of the Asiwaju of Edeland, Governor of Osun State, Senator Ademola Adeleke, was massive.

The weather was not extremely inclement, but staying under the noon sun without feeling the heat would have been challenging.

However, the jubilant people of Ila Orangun, who had seemingly been neglected despite having one of their own, Chief Bisi Akande, serve as governor of the state, were in high spirits, exhibiting unrestrained elation.

Many of them, in appreciation of the landmark project deemed necessary for the ancient community, danced, vibrating, turning, and twisting to the high-tempo Fuji sound being played by the live band that kept the ambiance alive, pending the arrival of the governor.

The siren announcing the approaching convoy of Governor Adeleke, who was accompanied by a handful of his aides, suddenly heightened the excitement that filled the air.

The Orangun, resplendent in his majesty, with his chiefs and prominent indigenes of the town, was joined by top government officials hailing from the town, seated at the entrance to the palace, where the groundbreaking of the project took place, and warmly welcomed Adeleke as his convoy came to a halt.

Also seated at the gathering to receive the governor were the Orangun of Oke IIa, Oba Adedokun Abolarin; the Akesin of Ora; the Asaoni of Ora; and other royal fathers across Igbomina land.

Amid thunderous applause and shouts of "Imole," Adeleke, in his remarks at the event, affirmed that his pact of service with the people of Osun is unbreakable and sustainable, repeating his vow to deepen the service relationship with the people of the state.

Moved by the massive reception from the people of Ila Orangun, Adeleke expressed his commitment to

delivering on his five-point agenda and other electoral promises, stressing that IIa Orangun and other cities are being positively impacted by his administration.

The governor narrated that his administration has so far completed the reconstruction, rehabilitation, and renovation of over 200 kilometers of roads, while several dualization and flyover projects are at various stages of completion.

"The Ilesa dualization project is 78 percent completed; the Ile-Ife flyover project is 75 percent completed; the Oke-Fia flyover is over 95 percent done, while the LAMECO flyover is about 55 percent executed.

"I am equally glad to inform you at this august gathering that the 1.5 kilometers of roads across all the Local Government Areas of the State are almost completed in their entirety.

The Oke Gada bridge is 100 percent completed.

"For the records, we have completed the construction of about 2KM length of Oba Jinsin/Ita Obajoko road, Ogunlade Junction - Kamila Junction road, and Ajagunla Street. Also, 1.8KM length of the rehabilitation/construction of Aregun Junction - Ogunlolu road has also been completed in Ila

"My dear people of the State, while the first phase of the infrastructure projects is being successfully executed, today we are announcing the takeoff of the dualization of the 1st phase of 3.5KM length of IIa Township Road, and this project will be delivered in 10 months by the grace of God.

"As part of my government's efforts to open up Osun state through road infrastructure, I have also approved the rehabilitation of Ila-Ora-Oke Ila road. The rehabilitation job has reached Oke Ila junction, and I want to assure the Orangun of Oke-Ila, the Akesin of Ora, the Asaoni of Ora, and my people in Ora that the job will continue shortly," the state governor declared.

The Orangun of IIa, while addressing the gathering, appreciated the performance of the governor since he assumed office, citing several completed and ongoing projects and programs across the state.

Both the Commissioner for Commerce and Industry, Rev. Bunmi Jenyo, and Hon. Ayo Awolowo, and the Member of the House of Representatives representing the

Ila/Ifedayo/Boluwaduro federal constituency, Hon. Clement Akanni, who coordinated the massive reception, expressed appreciation to the Governor for projects already completed and the dualization of the Ila township road that had just been flagged off.

Days after the dualization flag-off, the landmark event dominated public discussions in Ila Orangun, with many wondering why real development had eluded the town.

While many people are of the opinion that those in positions to influence development in the direction of the community don't really care, others were of the view that lla was just a beneficiary of the deliberate efforts by the incumbent governor to place politics aside and pursue real development in major towns across the state.

Contributing to the debate on the lack of development in IIa despite having political bigwigs as indigenes, a clergy member based in the Isedo area of the town, Pastor John Olabisi, said, "Maybe God ministered to Adeleke to do this for us in this community. We are the forgotten ones.

"Those we look up to as leaders in politics have been using us to make brisk political business without showing any real intent to improve the lives of the residents by using their influence to bring development to IIa. This dual carriageway by Adeleke will definitely transform this community from a big village that it is to a modern town good enough to attract investors to come in and create jobs."

Another resident, Oloye Dauda Gbadamonsi, while commenting on the decision by the Adeleke administration to give Ila its first dual carriageway, said the incumbent governor has created history and written his name in gold on the minds of the people.

"He could have looked elsewhere, but he decided to look at the plight of the people living in IIa. It's a special gift to us, the forgotten ones.

"Maybe because IIa is a bit far from the state capital, previous administrations have not given us the kind of attention we deserve in this town. We sincerely appreciate him, and we should speak loudly with our votes during the next governorship," Gbadamonsi further said.



sun born Super Falcons captain, Rasheedat Ajibade has led the Nigerian team to an historical win in Morocco at the final of Women's Africa Championship.

The Super Falcons of Nigeria led by the Ikirun native, Rasheedat Ajibade etched their name further into the annals of African football history by winning the 2024 Women's Africa Cup of Nations (WAFCON), clinching their record-extending 10th continental title tonight, in Rabat over Morocco in accomplishing the "Mission X" set for the team by the Nigeria Football Federation (NFF).

In a thrilling final that showcased their resilience, skill, and championship pedigree, the Falcons overcame their opponents to reaffirm their dominance in women's football on the continent.

Morocco's Atlas Lionesses had the full-capacity Stade Olympique de Rabat breathing heavily after a superlative opening performance that saw them take a two-goal lead after 24 minutes of the explosive encounter.

The Super Falcons thereafter came from a two goals down to defeat the host nation, Morocco by three goals.

The victory not only cements Nigeria's position as Africa's most successful women's national team but also highlights the team's relentless pursuit of excellence over the years.

competition from emerging powerhouses like South Africa, Morocco, and Zambia."


Nigeria captain Rasheedat Ajibade was named Player of the Tournament, with Africa's best goalkeeper for the past two years, Chiamaka Nnadozie was named Goalkeeper of the Tournament, while Esther Okoronkwo was named Woman of the Match of the thrilling and pulsating final game of the competition.

At the Championship, the Super Falcons defeated all the three teams that had previously beaten them in the 2022 finals that was also held in Morocco.

They defeated Zambia 5-0 in the quarter finals of this year competition to avenge for a third-place defeat they suffered from the Zambians in 2022. In the semi finals,

they equally edged Banyana Banyana of South Africa who had equally beaten them 2-1 in the group stage in 2022.

In the final, they defeated the host nation, Atlas Lionesses of Morocco that had previously beaten them on penalty shootout in the semi finals in 2022 edition of the competition while the team equally kept to their record of never losing a Women AFCON Final since the competition started.



Nigeria's women's basketball team, D'Tigress, made history on Sunday by defeating Mali 78-64 to secure an unprecedented fifth consecutive FIBA Women's AfroBasket title.

The final was one of the most challenging encounters for Nigeria in the tournament, as Mali came out with intensity and determination, eager to break Nigeria's dominance and end their remarkable winning run.

Despite trailing in the first quarter 26-21, D'Tigress rallied back with a resilient performance in the second quarter, tying the game at 41-41 by halftime. From there, Nigeria turned up the heat in the third and fourth quarters, gradually pulling away to seal victory and extend their winning streak at the AfroBasket to 29 consecutive games, a run that began after the thirdplace match in the 2015 edition held in Yaoundé, Cameroon.

With this triumph, Nigeria now boasts a total of seven AfroBasket titles, further cementing their status as Africa's most dominant team in women's basketball since 2015.

Team captain Amy Okonkwo delivered a standout performance, scoring 19 points, shooting 7-of-11 from the field and 4-of-7 from beyond the arc. She played the entire game and was deservingly named the 2025 FIBA Women's AfroBasket Most Valuable Player (MVP), repeating her MVP win from 2023.

Okonkwo now joins an elite list of two-time MVP winners, including Mfon Udoka (2003, 2005), Aya Traore (2009, 2015), and Nacissela Mauricio (2011, 2013).

Ezinne Kalu led Nigeria's scoring with 20 points, while Victoria Macaulay added to the team's firepower, combining with Okonkwo and Kalu for a total of 49 points, more than half of Nigeria's final tally.

## UNIOSUN Wins Two FG-NRF Research 2025 Grants

Osun State University has emerged winner of two Federal Government's 2025 National Research Fund (FG-NRF) out of the 158 competitive research grants awarded Nationwide.

According to a statement by the University Public Relations Officer, Ademola Adesoji, the first grant was awarded to Professor Kolapo Olusola-Eleka of the Department of Building, alongside his co-researchers while the second grant was secured by Professor Adetunji Kehinde of the Department of Agricultural Economics and his team.

The statement noted that hhis dual achievement not only reflects UNIOSUN's commitment to impact-driven research but also marks the third consecutive year the University has featured.

"The first grant was awarded to Professor Kolapo Olusola-Eleka of the Department of Building, alongside his co-researchers, for their project titled: "Enhancing Buildability in Urban Infrastructure Projects in Nigeria through Innovative Construction Techniques."

The research seeks to tackle critical challenges in urban development by introducing modern methods aimed at improving construction efficiency and quality across Nigerian cities.

"The second grant was secured by Professor Adetunji Kehinde of the Department of Agricultural Economics and his team for a project titled: "Promoting Responsible Agrochemical Practices to Mitigate Health Risks and Enhance Sustainable Production among Arable Crop Farmers in Southwest Nigeria." The study is designed to promote safe agrochemical usage and sustainable farming practices, with a focus on safeguarding the health of farmers and consumers while enhancing agricultural productivity.
